The City of Livermore's noise ordinance, Livermore Municipal Code Section 9.36, states, in part, regarding the time restrictions, "... at any time or place so as to annoy or disturb the quiet, comfort or repose of persons in any office or in any dwelling, hotel or other type of residence, or of any persons in the vicinity, is prohibited." So, there is no specific time where the ordinance is not in effect. This ordinance is in effect 24-hours per day.

The Castilleja del Arroyo HOA CC&Rs, section 3.3, states, "Noxious Activity: No noxious or offensive activity shall be carried on within any Unit or upon the Common Area, nor shall anything be done, placed, or kept thereon which may be or become a nuisance or cause embarrassment, disturbance, or annoyance to other Owners or interfere in their enjoyment of their property or the Common Area. No waste shall be committed upon the Common Area."

Please remember that we all live very close to each other. Our walls are thin and just about any noise you make can be heard. Slamming doors, pounding up and down the stairs, running your dishwasher and garbage disposal, rattling your dishes, even taking a shower all produce noise that can disturb your neighbors. Try to be aware of the noises you are making, and ask yourself if they might be causing a disturbance.

Please treat each other kindly.

There are STOP signs and Speed Bumps located in both of our driveways. These are there to remind you to slow down and STOP in areas where children might be playing. ## "Open Flames" and BBQs

A question came up recently about whether fire pits or fire places, such as a Chiminea, are allowed. The HOA Board recently discussed this exact issue and clarified the rules as such:

1. Only ready-made retail-purchased BBQs may be used, and
2. The flame may only be used for preparing food.

Therefore, no fire pits of any type nor any fire places, such as a Chiminea, are allowed. And, you cannot use the authorized BBQs as a heat source. Please contact management at 925-290-7456 if you have any questions.
