New Monthly Assessments & Payment Grace Period

If you make your monthly assessment payments through your bank's Bill Pay system or you send in a check through the mail, please remember to **change the amount you pay starting January 1, 2026**. The new amount was shown in the annual mail-out you received last month. If your payments are made by ACH payments through the HOA's bank, Heritage Bank of Commerce, the amount will automatically change.

Payment books are no longer sent out to every unit automatically. If you need a payment book, please contact management at 925-290-7456 and one will be sent to you.

Also, please remember all payments are due on the 1^{st} of every month and the grace period is now until the 3^{rd} of the month. Any monthly assessment payments received after the 3^{rd} of the month will be assessed a \$50 late fee.

Project Updates

The driveway sealcoating and re-striping project has been cancelled for 2025 due to the uncertainty of the weather. We will be rescheduling this project for the spring of 2026.

Holiday Decorations

Holiday decorations may be put up no sooner than two weeks prior to the holiday period. They must be removed within one week after the holiday period is over.

Please do not damage the Association property when you put your decorations up. For example, drilling any holes or installing any permanent nails, screws, hooks, etc., is not allowed Please remember, balconies and back patio areas are not part of your unit, they are Association property.

Smoking

The CDA HOA rule regarding smoking is:

No smoking is allowed inside any Unit. Also, there is no smoking allowed close enough to any CDA building that allows smoke to enter any Unit window or door.

When you need to smoke, please respect your neighbors and go out into the parking area, away from the buildings. Thank you!

Laundry Rooms

Due to significant increases in utility and repair costs, starting January 1, 2026, the cost for washing will increase from \$2.75 to \$3.25. The cost for drying will remain at \$1.75.

Also, one of the laundry room rules states: "Clothes left in any machine for more than 30 minutes past the end of the cycle may be removed from the machine so the machine can be made available to another resident."

It can be upsetting to return to the laundry room and find your clothes removed from the machine. But we are sure you understand the need to make the laundry machines available to all residents, and we would ask that you set a timer when you use the machines so you can get your clothes out in a timely manner.

For those of you that find yourself needing to remove someone else's clothes from a machine, we would ask that when you remove them to please be respectful of their clothes and place them on the folding table. We are sure you would want that courtesy if it was your clothes that were being removed.

We all share these machines. Please be kind to each other.
